## Parliamentary Contributory Pension Fund (PCPF) IPSA Consultation on MPs' Pensions and McCloud: Mitigating Adverse Tax Consequences

I trust this letter finds you well. We are writing to inform you about the next steps in the McCloud project.

On 19 October, it is expected that the Independent Parliamentary Standards Authority (IPSA) will release a consultation document that addresses MPs' pensions and the McCloud issue, specifically focusing on mitigating adverse tax consequences in relation to member choices.

This IPSA Consultation is an important step in the McCloud response and ensuring that members are treated fairly when it comes to tax treatment. This would mean not experiencing adverse tax consequences as a direct result of your McCloud choice which you would otherwise not have been subject to. The PCPF Trustees are a statutory consultee to all consultations regarding the pension scheme, and we will of course respond to this consultation in our official capacity. However, your participation and feedback to the consultation would also be greatly appreciated, as we navigate the complexities surrounding MPs' pensions and address the implications of the McCloud Response for the PCPF.

The forthcoming consultation covers aspects of the proposed McCloud response including the proposed objectives and scope of potential tax mitigations, as well as the process and timing of the implementation of decisions. Members should note that IPSA are currently proposing that the earliest that redress for adverse tax consequences of their McCloud choice would be available is 6 April 2025.

The consultation also covers a few other technical issues that have been discovered recently, such as insufficient retirement options for members at age 75 within the CARE section (to align with the options in the Final Salary section), incorrect revaluation of retained benefits for those now in the CARE section, and more generally a lack of discretion for Trustees to deal with complex cases. Please feel free to comment on these aspects of the consultation should you wish, especially if you are impacted by these issues and would like IPSA to take your views on board when establishing the policy in these areas.
